4a (Code:) (Expenses \$ 1,926,544 including grants of \$ 0) (Revenue \$ 58,552) During fiscal year 2011-2012, Maitri served a total of 49 (non-duplicate) residents; 11 deaths and 27 discharges during this period. With the advent of increasingly effective HIV drug therapies, the need for skilled nursing care has grown as people living with HIV/AIDS ("PLWHA") are living longer and require more complicated treatments. In addition to hospice care, Maitri also provides 24-hour skilled nursing care for those with medical conditions that require short-term stabilization ("respite care"), and then provides support in transitioning them into less restrictive placements. Nursing and attendant care staffing, including home health aides and a Licensed Vocational Nurse supervised by a full-time RN Case Manager, are on site at all times. The combination of improved anti-retroviral medications and the intensive care at Maitri has resulted in more of our residents living longer and requiring respite care instead of hospice care. As a result, ensuring resident compliance with anti-retroviral therapies has become an increasingly important role for Maitri nursing staff. (continued below) []

4b (Code:) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 0) Over 25,000 meals were served to 49 residents. Food and nutrition are critical components of the care that we provide. Maitri prepares three daily meals for 365 days per year with special attention paid to the nutritional requirements of HIV drug therapies, conditions specific to each resident, cultural and taste preferences, and the context of family and community in which the meals are presented. An on-staff Social Worker provided guidance to 49 residents accessing community resources and benefits, mental health services, and spiritual care, while working with their caregivers and loved ones to provide respite and bereavement support. As fewer residents require hospice, we are increasingly involved in collaborative efforts with other community service providers to assist those residents who become capable of leaving Maitri and resuming a life independent of institutional care. []

receipt. This acknowledgment form is filed in the employee's personnel file. In addition, the
Conflict of Interest Policy is stated in the board by-laws and, going forward, board members
will be required to sign a statement at the end of each fiscal year affirming no conflicts of
interest have occurred within the fiscal year.

Form 990 Part VI Section B Line 15 a/b - An HR consultant with expertise on the subject was
hired to determine an appropriate salary range recommendation for every position at Maitri in
2011. This determination was based on prevailing local market salaries for comparable
positions using at least 2 independent salary surveys as reference. The low end of the salary
range is set at a 25% level (meaning 3 out of 4 comparable positions outside of Maitri earn
MORE) and the maximum of the salary range is set at a 75% level (meaning 3 out of 4 comparable
positions outside of Maitri earn LESS). The Executive Director compensation was set at the
MINIMUM of the established salary range, based on a board vote. This followed the board vote
to approve the salary ranges for all positions at Maitri. The compensation study is being
updated in Q2'13 based on updated independent marketplace survey data.
